



EVENT SPONSORSHIP AGREEMENT: 2025 - 2027

This Sponsorship Agreement (the “Agreement”) is made effective as of May 16, 2025, by and between Turning Point USA (“TPUSA”) and **International Fellowship of Christians and Jews**. Each of TPUSA and **International Fellowship of Christians and Jews** may be referred to hereinafter as a “Party” or collectively as the “Parties.”

Turning Point USA is a 501(c)3 non-profit organization founded in 2012 by Charlie Kirk. The organization's mission is to identify, educate, train, and organize students to promote the principles of freedom, free markets, and limited government.

Since its founding, Turning Point USA has embarked on a mission to build the most organized, active, and powerful conservative grassroots activist network on high school and college campuses across the country. With a presence on over 3,500 campuses, Turning Point USA is the largest and fastest-growing youth organization in America.

In consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

IV. Status of TPUSA

(a) TPUSA is a 501(c)3 non-profit organization, and nothing in this Agreement shall be construed or inferred to imply that **International Fellowship of Christians and Jews** is a partner, joint venturer, or agent of any of TPUSA or any of its affiliates. The Parties are independent of each other and the agreement does not equal an endorsement. **International Fellowship of Christians and Jews** shall have no authority to act as an agent of TPUSA and shall not represent the contrary to any person. TPUSA shall organize, host and produce the Event and otherwise perform its duties hereunder in accordance with all applicable laws, regulations, rules and orders, with fidelity, and to the best of its ability. The manner in which the Events take place and in which TPUSA performs its duties hereunder shall be at TPUSA's discretion; provided, however, that TPUSA and its employees and representatives shall at all times conduct themselves with a standard of professionalism consistent with professionals in its field.

(b) The relationship between TPUSA and **International Fellowship of Christians and Jews** provided for hereunder is not exclusive and TPUSA, at its discretion, may solicit and accept Event sponsorship arrangements with other third-parties under the same or similar terms.

V. Expenses

Please note that all other expenses not agreed to prior are the responsibility of **International Fellowship of Christians and Jews**. TPUSA does not provide hotel rooms for exhibitors as TPUSA provides lodging solely for student attendees at a subsidized rate. Exhibitors will also be responsible for other items including but not limited to wifi, meals, shipping, parking, etc.

TPUSA is not responsible for exhibitor items that may be lost or stolen during the event.

VI. Event Requirements

TPUSA has set aside designated times for meeting exhibitors and attending breakout sessions during the event. Please be prepared for heavy traffic at these times, as well as before and after the program each day. Organization is required to be present at the booth during required event times listed in the detailed sponsorship information packet. Failure to abide by times will result in a fine of \$100 due no later than one week after the event.



VII. Indemnification

(i) “Affiliates” shall mean a Party, its parents, subsidiaries, and members, and the directors, officers, employees, or agents of the foregoing.

(ii) The Parties shall indemnify, defend, and hold harmless each other and their Affiliates for any losses, judgments, costs, or expenses (including reasonable attorney fees and costs of litigation) arising from or relating to a claim, demand, suit, or action asserted by a third party (i.e., not the indemnified Party or its Affiliate), in which the injury or damage alleged by such third party was proximately caused by the negligence (including negligent failure to maintain, set up, procure, or host premises in a safe condition), gross negligence, willful misconduct, or fraud of the indemnifying Party or any of its Affiliates, provided that there shall be no indemnity or defense available to an indemnified Party or Affiliate whose own negligence also proximately caused the injury or damage.

(iii) In the event any Party seeks coverage under this paragraph for itself or its Affiliate, the Party shall provide prompt notice to the indemnifying Party and shall not settle or resolve the underlying claim absent the indemnifying Party’s consent, except that failure to provide notice of a claim shall be a defense only if the failure materially prejudiced the indemnifying Party’s rights and interests hereunder.

VIII. Deadlines

TPUSA will designate deadlines for certain deliverables in a sponsor logistics packet prior to each event. It is the responsibility of the sponsor to provide the necessary items on time to allow our team to execute on the deliverables. If items are not given to our team by the deadlines listed, TPUSA will no longer be contractually obligated to execute on those deliverables.

IX. Organization’s Logo

International Fellowship of Christians and Jews gives the rights to TPUSA to use its logo as specified in the terms laid out in section III of this agreement. **International Fellowship of Christians and Jews** will provide to TPUSA a high resolution, .ai or .eps version of its logo to use.

X. Cancellation

In the event that Turning Point USA has to unexpectedly cancel and/or reschedule the event(s) for a later date, TPUSA will first offer to move the current sponsorship to the new event date without any charge and/or penalty. Please note TPUSA will schedule the event for a later date in



the same year. The second option TPUSA will offer is to transfer the sponsorship to a similar TPUSA event within the impacted event's calendar year.

XI. Agreement

Both parties hereby agree to this Agreement and acknowledge that the agreement will be terminated after the events have ended. Both parties also agree that everything in this agreement is confidential.
